### ORDER

1. As per the Government Order read above, scale of pay of State Government Employees and Teachers have been revised w.e.f 01/07/2009. The Higher Secondary School Teachers are eligible for two time bound higher grades i.e., Higher Grade on completion of 8 years and Selection Grade on completion of 15 years. Certain Higher Secondary School Teachers got promotion as Principal after getting the first Time Bound Higher Grade promotion, whereas certain others got promotion before completing the required period for higher grade promotion. This creates a situation of juniors getting higher pay than the seniors. Several representations have been received from various service organisations to rectify the anomaly by giving notional fixation to Principals in their Higher Grade post of Higher Secondary School Teacher.

2. Government have examined the matter in detail and are pleased to grant notional Time Bound Higher Grade fixation to Principals of Higher Secondary Education as per rule 28-A Part I KSR on due dates on completion of 8 years of service as Higher Secondary School Teacher and there after

their pay will be fixed in the Principal post on the same date and monetary benefit on that account will be only w.e.f 01/02/2011
